



**NOTICE OF PROPOSED SOLE SOURCE PROCUREMENT**  
**this is not a competitive bid/proposal**

The Utah Transit Authority (UTA) Procurement Policy provides that sole source procurements may be used only when the Award of a Contract is infeasible under other source selection methods, and at least one of the following circumstances applies: (a) The required goods or services are of a specialized nature requiring expertise that is only available from a single source; (b) The public exigency or emergency for the required goods or services will not permit a delay resulting from competitive solicitations; (c) After solicitations of a number of sources, competition is determined inadequate.

The UTA Purchasing Department has received a request to make the following sole source procurement:

**Product and/or Service to be purchased: Construction services to repair/construct the south bridge abutment and adjoining trail on the Lehi Pedestrian Bridge due to a meteorological event**

**Contract Duration: Estimated repair time 3 months.**

**Proposed Sole Source Supplier:** Granite Construction Company

**Estimated Total: \$799,272.56**

**Sole Source Justification:** Public safety in a quick and effective repair of the bridge damage caused by environmental factors. Granite’s construction techniques and site-specific knowledge of the approach/sleeper slab’s connection detail to the bridge deck and associated bridge sub-structure. Also, the specific expansion joint methods and materials will eliminate potential pedestrian hazards associated with this structure.
